### Your Water Quality

This Annual Water Quality Report is designed to inform you about the quality of the water delivered to you every day. Our goal is to provide you with a safe and dependable supply of drinking water.

This report contains information for monitoring for the period of January 1st to December 31st, 2025 and is a snapshot of the quality of water provided last year. Included are details about where your water comes from, what it contains, and how it compares to standards set by regulatory agencies.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the EPA's Safe Drinking Water Hotline (800-426-4791).

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide for public health.

### The Source of Your Water

Your public water system at Birchview Townhome Condominiums - is a Community Water System (PWSID 220310) and the source is a groundwater well located in your subdivision. A survey was completed in 2024. Your next survey will be in 2027.

The State of Alaska has completed a Source Water Assessment for the water system at Birchview Townhome Condominiums. You may review a copy at the Alaska Resources Library & Information Services (ARLIS) located at 3211 Providence Drive, Room 111 Anchorage, AK 99508: phone number 907-272-7547.

In this Source Water Assessment, the Wellhead/Surface Intake and Aquifer Susceptibility were ranked at **Medium**. The overall vulnerability for contaminants is **Medium** for Bacteria & Viruses, and Nitrates/Nitrites, and **Low** for Volatile Organic, Synthetic Organic, Other Organic Chemicals and Inorganics/Heavy Metals.



### Water Sources & Contaminants

**Water Sources:** The sources of drinking water (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

#### **Possible Contaminants in Source Water:**

- ✓ Microbial Contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- ✓ Inorganic Contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming.
- ✓ Pesticides and Herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- ✓ Organic Chemical Contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- ✓ Radioactive Contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

## Water System Test Results

By regulation we are allowed to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though representative, are more than one year old.

### **Other Information**

Birchview Townhome Condominiums is working with a private Engineer to provide a submittal to the State of Alaska DEC Drinking Water Program to apply for Interim and Final Approval to Operate for the water system.

## Helpful Definitions and Abbreviations

**Maximum Contaminant Level (MCL):** The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**Maximum Contaminant Level Goal (MCLG):** The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**Maximum Residual Disinfectant Level (MRDL):** The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

**Maximum Residual Disinfectant Level Goal (MRDLG):** The level of a drinking water disinfectant below which there is no known or expected risk to

health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

**Non-Detects (ND)** – laboratory analysis indicates that the constituent is not present.

**Parts per million (ppm) or Milligrams per liter (mg/l)** – one part per million corresponds to one minute in two years or a single penny in \$10,000.

**Parts per billion (ppb) or Micrograms per liter** – one part per billion corresponds to one minute in 2000 years.

**Action Level (AL)** – the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

**Treatment Technique (TT)** – A required process intended to reduce the level of a contaminant in drinking water.

## **Reduction of Monitoring Requirements**

As authorized and approved by the EPA, the State has reduced monitoring requirements for certain contaminants to less often than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. Some of the data in our Test Table, though representative, is more than one year old. We have monitoring waivers from the State of Alaska DEC for Synthetic Organic Contaminants (SOC's) and Asbestos.



## **Lead in Drinking Water**



Lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Birchview Townhome Condominiums is responsible for providing high quality drinking water and removing lead pipes but cannot control the variety of materials used in plumbing components in your home. You share the responsibility for protecting yourself and your family from the lead in your home plumbing. You can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Before drinking tap water, flush your pipes for several minutes by running your tap, taking a shower, doing laundry or a load of dishes. You can also use a filter certified by an American National Standards Institute accredited certifier to reduce lead in drinking water. ## **Lead Service Line Inventory (LSLI)**
